The bidder should have executed a single order equivalent to at least 30% of the estimated cost of works during the last three years of financial years (i.e., FY 2006-07,2007-08 and 2008-09); the single order shall be of similar nature of work.

The bidder should have valid Electrical Contractors Licence/MVAT/Service Tax Registration / PF Registration labour laws etc.
